The challenge and excitement of the field of aging continues to grow! This year we began to seek new roles to extend our expertise. We are looking forward to entering new territories toward which we have already taken the first, confident steps.

We and other local partners are embarked on a new partnership to help individuals on Medicaid better manage their chronic disease... one of several new initiatives to help integrate social and medical benefits for improved health.

We are sincerely grateful to all of our many donors without whom we could not have accomplished so much. We hope several pilots will

succeed in generating revenue for programs that serve low income seniors. Our Meals on Wheels program is testing a new high-end frozen home-delivered meal. A new program, Story Tell...Keeping Memories Alive, offers help to make audio and video recordings to share with family members.

New grants are helping us improve what we do and reach more people. The Horizons Foundation gave funds for a study to understand how to support volunteering by boomers and others. The Paul G. Allen Family Foundation will support a two-year project to increase our organization's ability to serve elders from diverse backgrounds.

Back to the Future: A New Vision | Board President's Message

VISION: *A community where older adults and those who love them are empowered to choose and develop ever more joyful, healthful and meaningful lives.*

MISSION: *Promote the emotional, social, and physical well being of older adults.*

Senior Services represents a tree of life for everyone who is aging in our community. As we look forward to celebrating Senior Services' 40th Anniversary in 2007, it is wise to examine the roots of this tree, especially those who have nourished it. Thus we may gather more fruit from its branches in the future. At the same time, it is important not to allow one of the roots of this tree, senior centers, to wither unnecessarily.

Over the years, public and private support from hundreds of volunteers and financial contributors have fostered the founding and development of Senior Services created by United Way in 1967 as an umbrella agency to administer and coordinate programs for older adults. In 1974, United Way collaborated with the leaders of local city and county

government to form a local Area Agency on Aging authorized and funded by the federal Older American's Act and operated by the City of Seattle's Human Services Department. Representatives from United Way, Seattle, and King County continue to serve as the policy body, or Sponsors, of the Area Agency. In 1978 United Way also required that any senior center must go "under the umbrella" of Senior Services to receive its funding.

Currently, senior centers, one of our most important roots, face the challenge of acquiring adequate funding to provide activities and services for seniors born and raised during the Great Depression while planning for programs that meet the needs and interests of the Baby Boomers as they mature and age. As their priorities have changed, United Way's partial funding of senior centers has leveled. The Area Agency funds many Senior Services programs, but not senior center operations. Recently, the City of Seattle's City

Council has increased its investment in Seattle senior centers to help make up shortfalls in other fund sources.

The Board of Directors of Senior Services, carrying out one of its roles to set goals and approaches for meeting the needs of mature adults, will seek input and endorsement of an important document. We want comments on our Draft Goals and Approaches for City-Wide Planning and Coordination of Seattle Senior Programs from many stakeholders, including senior centers and their leaders and other interested community leaders, programs, and agencies that serve seniors. Our goals are 1) to develop a process for coordinating the activities of senior centers and programs while reducing costly duplication, and 2) to facilitate collaboration among senior centers and senior programs in increasing fund-raising capabilities.

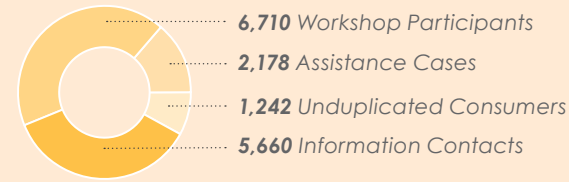

Who We Are

Senior Services is the largest private non-profit agency serving seniors in Washington State. We promote the well-being of older adults through core programs and services that encompass Information and Assistance Services, In-home Support Services, and Wellness.



2006 Highlights

65,436 requests for information were received by Senior Information and Assistance advocates –an increase of 12% over the previous year

SHIBA HelpLine assisted people with their health insurance issues 7,560 times this year and gave 81 public presentations and workshops

2,025 repairs to 987 seniors and individuals with disabilities were provided by the Minor Home Repair program, enabling the individuals to remain living safely in their own homes

Project Enhance received the 2006 International Council on Active Aging Industry Innovators Award, which recognizes the cutting-edge, active aging programs and the creativity and commitment to excellence of the organizations that originated them

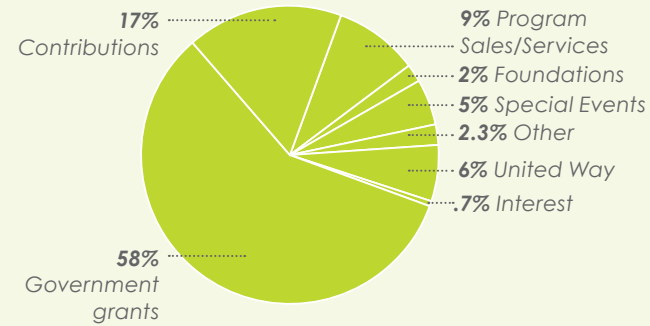

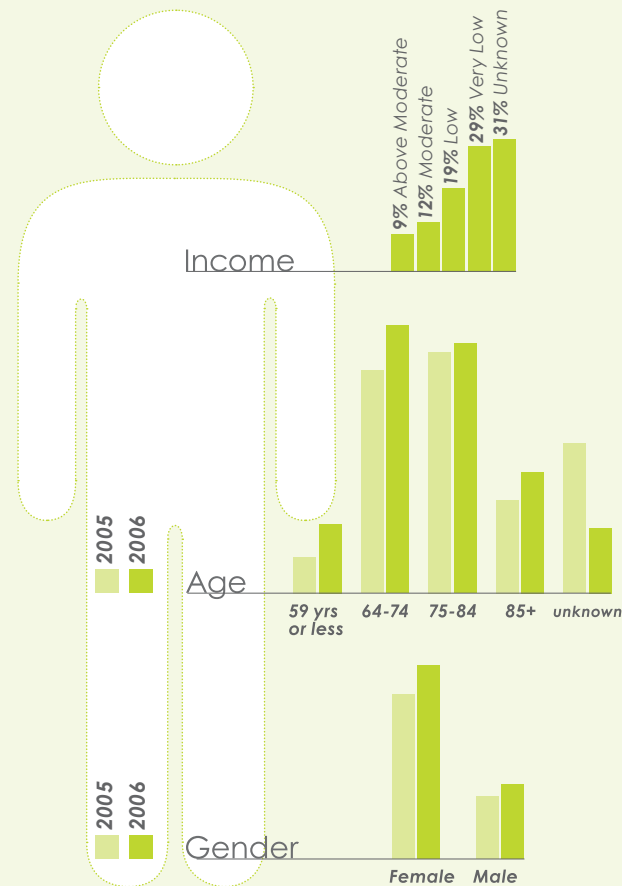
